Construction

Uprights & Cross Braces

- All welded 1" square tubular frame with rounded edges
- 1" cross brace for a rigid Frame support

Runners

- Tray runners are all stainless steel and fully welded to the frame
- Each runner angle measures 1" x 1-1/2" x 16 gauge thick

Casters

- High Quality 5" Polyurethane with full thread guard swivel plate casters that do not interfere with nesting capability.

- Casters Bolted to Wheel channel
