- Available in 2 and 3 Shelf Designs
- All Welded Frame

**Frame**

- **Heavy Duty (HD):** All welded frame is made from 1.25" square tubing

**Shelves**

- **Heavy Duty (HD):** Shelves are 14 gauge stainless steel (3 up, 1 down)

**Casters**

- **Heavy Duty (HD):** 6" x 2" Polyurethane casters for easy maneuverability, 2 rigid, 2 swivel with brakes
